 - These times may be adjusted if desired.

- Parties are reserved for a two hour block when space is available.
- All swimmers must wear a proper swimsuit and bring their own towel.
- Socks are required for play in the Kids' Gym.

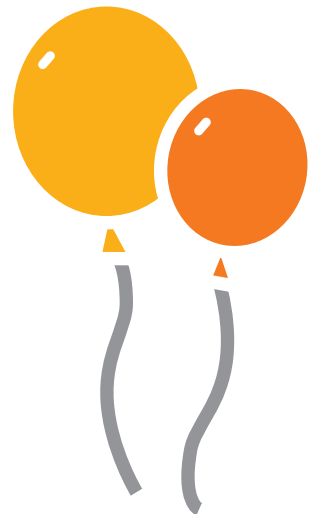
